



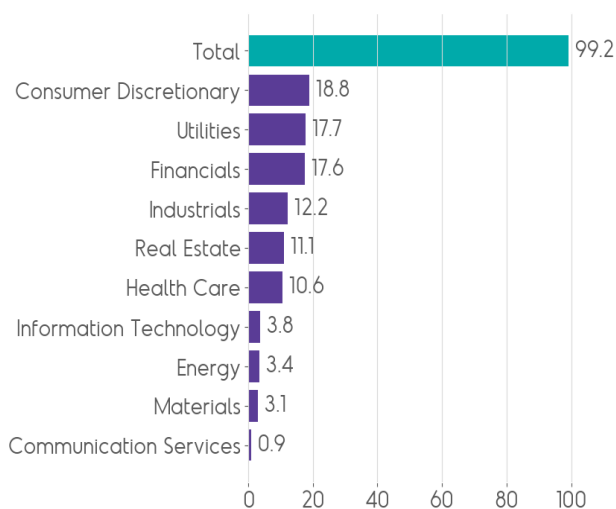
Aster Capital

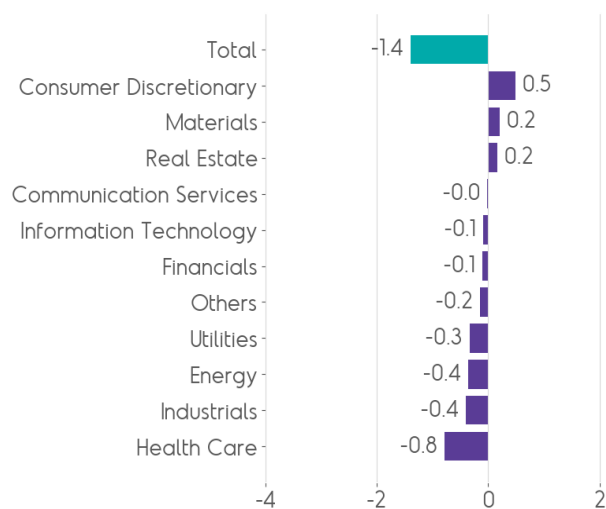
